DURING THE FISCAL YEAR, RESOURCE CENTER STAFF SUPPORTED 176 LICENSED PROGRAMS WITH QUALITY IMPROVEMENTS AND PARTICIPATION IN GREAT START TO QUALITY. IN ADDITION, RESOURCE CENTER STAFF OFFERED A TOTAL OF 26 GREAT START TO QUALITY ORIENTATION TRAININGS FOR A TOTAL OF 118 LICENSE-EXEMPT PROVIDER ATTENDEES.
